Representative Wenstrup:

The Vinton County Park District endorses Jackson County Water Company's application for Community Project Funding. Vinton County's Goosecreek Valley Project will bring water to at least 31 additional households on Pretty Run Road and Goosecreek Road that do not currently have a reliable source of potable water, in addition to multiple vacation rentals that are the backbone of our local tourism industry.

Together with the Jackson County Water Company's previously funded projects that are bringing water lines to Garrett Ridge and the intersection of Goosecreek and Pretty Run, this infrastructure project will complete a loop that will support the expansion of water service to over 300 households over the next decade and boost economic development in the area—an expansion of water service not seen in Vinton County in over twenty years. This will attract new tourism businesses in an area that is prime for that type of development. It's nearby to many existing lodging facilities and Le Petit Chevalier Farm Winery, as well as future potential park district properties.
