





This would be a great addition to our public boat launch and public use park area!

The estimated size of the dock is 8 feet by 20 feet with durability for wheelchair access. As we understand this grant application, if approved, would be 100% funded. The Village does agree to and pledges to maintain the access docks and to properly store and care for during the winter months as we do for our current docks we utilize.

This is a timely and requested addition for the communities situated on the Ohio River from Cincinnati to The Village of Aberdeen, and will add significantly to the leisure activities while enhancing quality of life through additional recreational opportunities.
