This is a letter of support as the Chair of the Clermont County Transportation Improvement District (TID) regarding the request for 2021 Surface Transportation Authorization funding for the Aicholtz Road Roundabouts Project (PID 108254).

The TID has coordinated with the Ohio Kentucky Indiana Regional Counsel of Governments (OKI), Ohio Department of Transportation (ODOT) and Union Township to continue moving forward on this important capital project. If successfully implemented, the project will substantially reduce congestion levels along the Aicholtz Road corridor and allow for continuation of development in that area. 
Mr. Evans,
